#### **Current Position**

Mr. Livingston is President/Owner of The Richstone Corporation, which he started in 1990 as an umbrella organization for his work in construction, home building and remodeling, land development, project management and consulting. During its 20+ years, Richstone has owned, renovated, and managed rental properties; constructed custom and production homes, developed raw land into finished building lots; renovated commercial interior spaces; and provided expert witness consulting and testimony. In residential building, the company uses the trade names Richstone Homes & Remodeling and Richstone Custom Homes. Richstone was the commercial general contractor of an interior rehab project at a local religious institution. Mr. Livingston has had a keen interest in green building before it became fashionable, served on the Board of the MBIA Green Building Council, and routinely implements green initiatives in Richstone's building projects.

#### **Professional Experience**

Mr. Livingston has more than 30 years of experience as owner and manager of several small building and development entities including Richstone, Cypress Homes of Maryland; Chateau Enclave Inc.; Ellwood Building Company and project specific LLCs and partnerships. During Mr. Livingston's tenure, these entities built more than 500 single- and multi-family residences and developed nearly 250 lots from raw land through municipal approval to improved lots and finished communities. Mr. Livingston directly managed and participated in every aspect of the building and development process including architectural design, contract negotiation, site supervision, estimating, subcontractor hiring/firing, sales and customer relations, quality control, and warranty oversight. He has also personally managed numerous additions and renovations including seven MBIA Remodeling Award of Excellence winners in 2014 through 2016. He was featured on the cover page of the Baltimore Sun Real Estate section for his gated community, The Enclave, and he built the "Cotswold Charm" house featured in the May, 2009, issue of Chesapeake Home magazine.
